

WHAT WE DO & WHAT WE OFFER

We provide proper solid waste management for various companies in different industries. Our services include waste segregation, on-site storage, collection, transfer and transport, processing and recovery, and disposal. In addition, we also cater for the transportation of hazardous wastes.



SCRAP AND RESIDUAL WASTE HAULING

We collect partially segregated waste materials as per requirement of each company, and transport it to our material recovery facility [MRF]. Then, we do secondary segregation of all solid waste materials according to their respective categories. The recycling and resale of the segregated materials follows. After that, we clean and disinfect the material recovery facilities of each company, keeping their areas free from garbage and/or spillage of grease trap wastes. We also composte food wastes or convert them into animal feed. We then dispose all residual wastes to DENR authorized controlled dump sites or sanitary landfills.



HAZARDOUS WASTE TRANSPORTER

We are also licensed to transport hazardous waste from their point of generation to the facilities of partner companies that provide proper treatment and disposal of these types of wastes.

HOW WE WORK

We have developed a system for proper collection and disposal of solid waste in compliance with R.A. 9003

All of our employees shall use methods that maximize the utilization of valuable resources and encourage the conservation and recovery of these resources. We must also ensure the proper delivery of our services through our trained employees.






OUR MATERIAL RECOVERY FACILITY



1. This Certificate of Registration is valid until **30 June 2018**, unless revoked earlier for violation of PEZA rules and regulations. In addition, after **31 December 2016**, this Certificate of Registration shall be valid only upon presentation by the Registered Enterprise of a valid current Mayor's Permit;
2. The Registered Enterprise, pursuant to its DENR Certificate of Non-Coverage No. LLDA 2008 157 9999, is authorized only to buy and/or sell scrap materials such as ceramic, paper, glass, plastic, wood, textile, rubber, leather and metals (except metals containing mixture of copper and lead compounds) generated by economic zone enterprises in the economic zones, **provided the materials do not contain any toxic and/or hazardous matter(s)**;
3. Appropriate taxes and import duties assessed by the Bureau of Customs on the scrap materials to be withdrawn from the economic zones shall be paid in the name of the economic zone enterprises which generated and sold them;
4. Scrap materials to be withdrawn shall be subject to inspection/examination by authorized PEZA personnel;
5. Scrap materials shall be taken out of the economic zones on the same day PEZA-EAD approves applications for withdrawal;
6. The Registered Enterprise shall only use open vans for loading scraps;
7. The Registered Enterprise shall comply with all other pertinent laws, rules and regulations of all other concerned government agencies;
8. This Certificate of Registration shall be for the sole use of the Registered Enterprise and shall not be transferred, copied or reproduced without proper PEZA authorization; and,
9. Any violation of these terms and conditions shall constitute automatic suspension of this Certificate of Registration.


